**Subject:** The importance of precedent



Hello Jack,

The fight for Election Integrity is not over. The Left is so desperately trying to hold on to their power that they are abusing the courts to hide evidence of Election Fraud from the people while threatening punitive sanctions to derail anyone from ever asking for Election Transparency again.

I have written you many times about the importance of precedent. I have written you that if the activist courts, empowered by Katie Hobbs and Adrian Fontes are able to simultaneously issue sanctions for filing an Election Fraud case too soon, and also for filing it too late, then it will necessarily make almost any future election challenges all but entirely moot.

But precedent can go the other way, and it appears as if the tides may be turning.

I will tell you an example eerily similar to what happened in Arizona, but with a different result, which elections being overturned entirely, and new elections called for.

This story comes from Berlin, Germany.



In Berlin, a judge overturned an election because of almost certain election fraud and problems with hundreds of polling stations in their last election. Sound familiar?

Indeed, dw.com reports:

Germany's constitutional court ruled on Wednesday that the state of Berlin would have to re-run its elections next year, after deciding that organizational chaos reported at hundreds of polling stations around the city last September made the vote invalid. The Berlin election will now have to be repeated within 90 days.

Presiding Judge Ludgera Selting said the decision had to be taken because of the "frequency and gravity" of the mistakes that had been made, which were so widespread that they may have altered the election result. Selting also spoke of "serious systemic flaws" in the preparation for the election.

Wilko Zicht, who runs the nonprofit electoral watchdog Wahlrecht, said the court's decision was certainly right. "Democracy rests on the fact that results are accepted, and that is only possible if you can trust the results," he told DW. "These mistakes could not have been corrected any other way." It would not have been fair, he argued, if the election were only repeated in areas that had reported problems.

Zicht also thinks Wednesday's decision should strengthen, rather than weaken, trust in democratic institutions. "I think the danger would have been greater if the verdict today had been different," he said. "Then you actually could have argued: Even if something has clearly gone wrong, how can they just carry on and not repeat the election.

Here, the German courts were able to look at a clearly fraudulent election with significant "organizational chaos" and then apply logic to it, and say that it must be thrown out!

This does beg a question though...

Why do the German courts care more about free and fair elections than Adrian Fontes, Katie Hobbs, and the Arizona courts?

There is clearly significant enough evidence to say that fraud and general "organizational chaos" easily altered the results of the 2022 election. So a new

election must be called for.

Remember this: When Germany is doing more to protect free and fair elections than the Left in the United States, you know there is a big problem.

And this is why the fight wages on. We must fight the courts, fight the sanctions, and continue the fight for Election Integrity. People around the state, around the nation, and around the world are waking up.
