Thus, for the reasons that follow, this Court should grant Secretary Fontes’ Motion.

It must be awfully convenient to write that there is “no evidence of misconduct, illegal voting, or how anything alleged affected the outcome of the 2022 General Election” when the activist judge didn’t even let us present our evidence in court, of which there is literally mountains of not only evidence, but highly incriminating evidence.

We knew the election machines had immense problems before the election. We sued. We were dismissed with prejudice because the election had not happened yet.

Now we saw that the election machines failures disenfranchised likely hundreds of thousands of voters. We sued. We were dismissed with prejudice because the election had already happened!

In neither case were we allowed to present our evidence.
