**SARASOTA, FL** — Since April 2021, skepticism has grown among likely voters regarding the November 2020 Presidential Election results. Many likely voters believe that election integrity affected the results of the 2020 elections. Through the efforts of a large group of citizens, organizations and a handful of elected officials, more and more information from different states is being brought to light, putting into question the reliability of our election process. 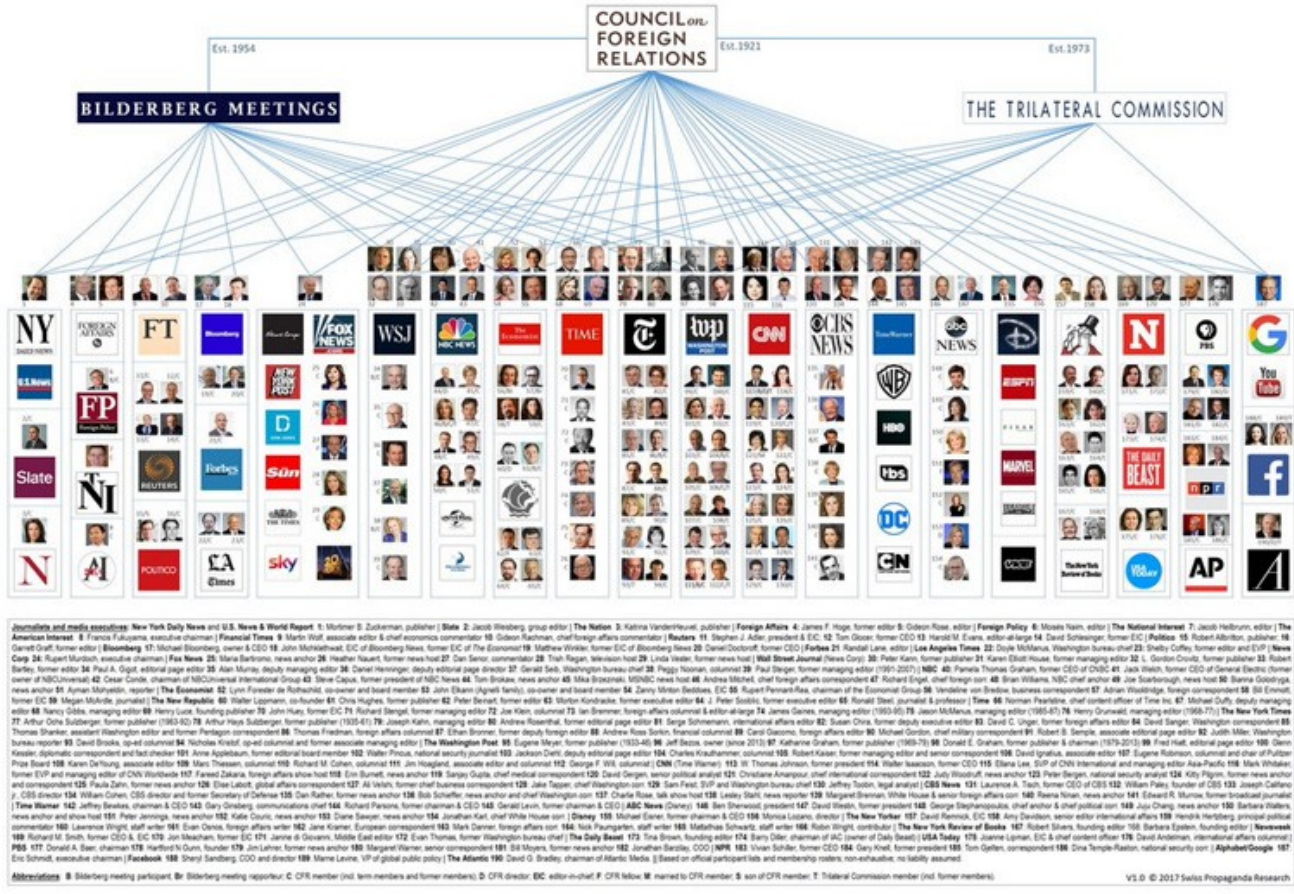

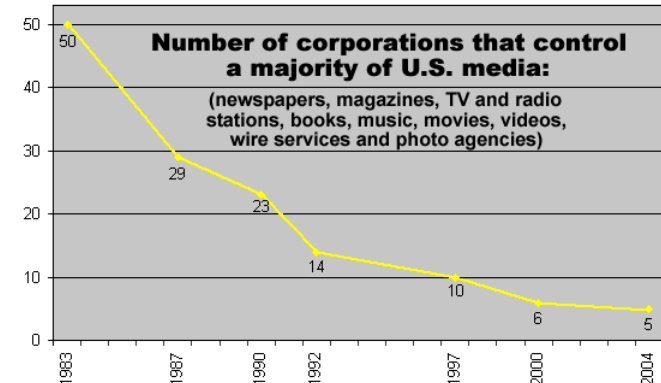

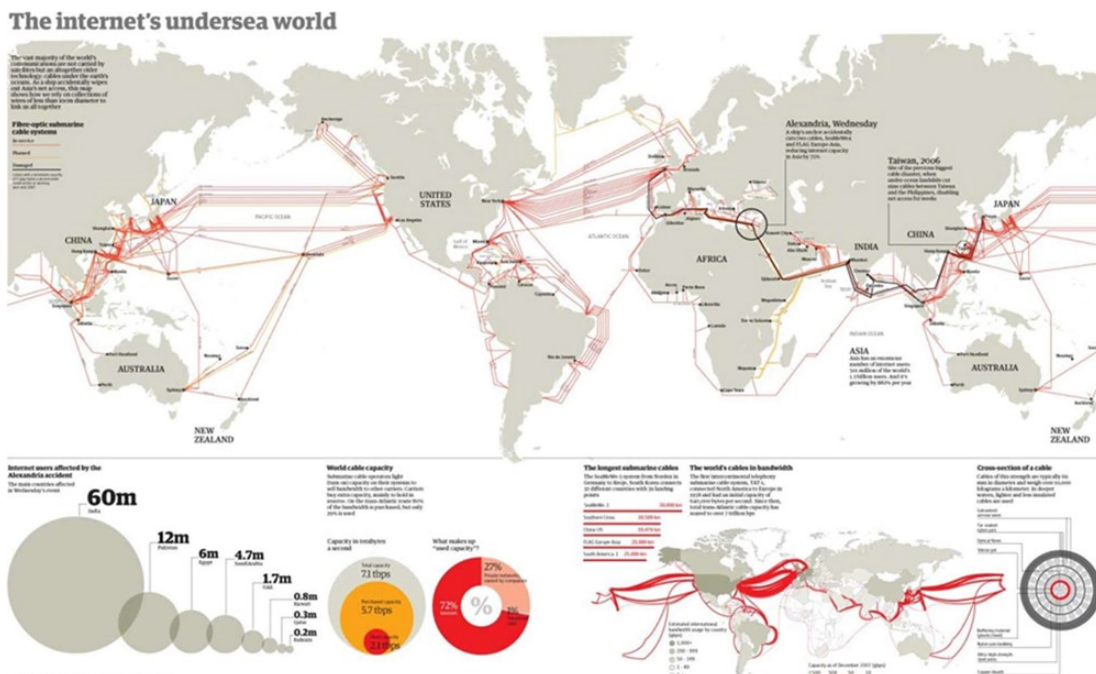
## **Why Do We Need Forensic Audits And How Do They Differ From State Required “Certification Audits?”**

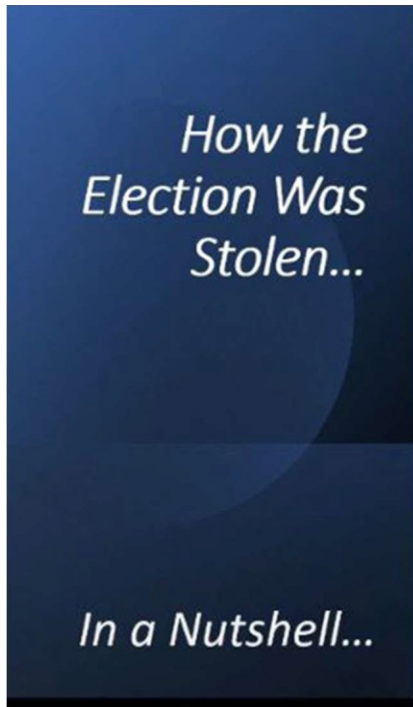

## II. Election 2020 - How It Got Stolen - Jack's Notes Summarizing

- Link title for this 26 page study done by Seth Keshel and Draza Smith edited by Theresa Holmes.
- There are 43 links to sites on How to Hack an Election in 7 Minutes (Aug 2016) in the first three pages for those who do not believe elections cannot be stolen.
- Biden inferred they had rigged the elections to assure his "election" - see front cover of his statements.
- The credentials of Dr. Douglas Frank, Draza Smith and Seth Keshel are very high and covered on Page 7 so this study in way credible. Dr. Frank politics is way left of center which makes this study even more balanced.
- In AZ the target machines were in the same county but the attacks came from different cities in China.
- Mike Lindell has the evidence to evaluate and has done so giving the proof of foreign intervention into our 2020 election.
- Logistically this was a massive attack.

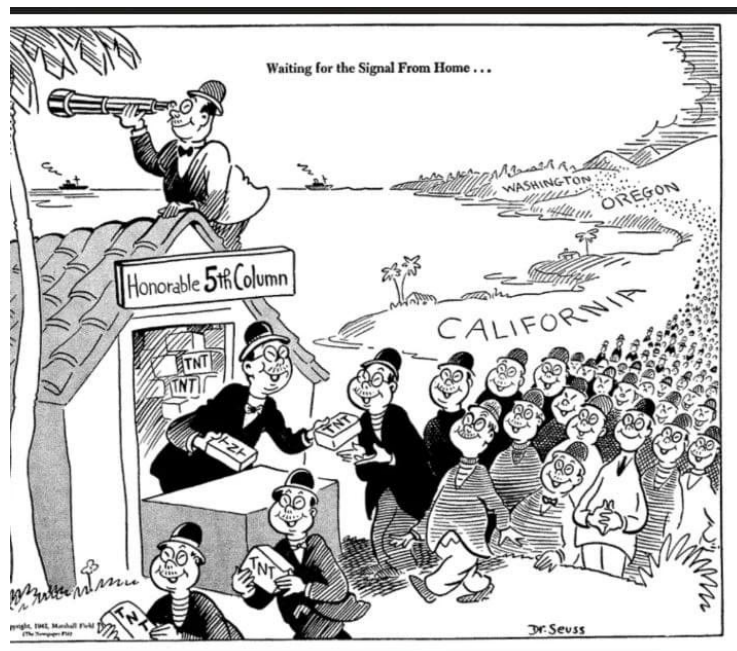

- Dr. Frank determined that a precise formula was used to control the election results.
- Dr. Frank says live cast voting machines were connected to the internet and that voter registration rolls are accessible online, voter registration rolls were artificially inflated with low propensity voters to supply a pool for phantom ballots.
- Over 30% of the ballots estimated were from phantom voters.
- After studying Pennsylvania, Dr. Frank studied Michigan, Wisconsin, Colorado, and other areas and found that the same essential patterns are in every state.
- There is significant corroboration evidence of the scheme across the nation.
- Analysis of the Edison election database there were three nearly identical pauses in vote counting in Georgia and Pennsylvania.
- Biden took the lead in both states at the end of the third pause.
- Edison data shows an increasing number of ballots for each candidate throughout the night but this year there was a unique phenomenon.
- Voting systems from Dominion, Election Systems & Software and other firms began reporting to Edison that thousands of votes were being switched from Trump to Biden.

- The largest switch was 220,883 of Trump's votes were switched to Biden and 941,248 votes were simply removed from their count.
- Edison's real time data has inadvertently revealed the greatest election fraud in American history.
- **Draza Smith says we need forensic audits, canvasses, arrests and legislation to preserve our elections or we don't have a country.**
- There were 299,493 impacted votes = 1/7th of the 2.089 million and this is the low end estimate. Election in Maricopa must be decertified!
- Above two comments came from Telegram.
- The cabal insisted they were fortifying the election.
- Smartmatic software is embedded in both Dominion and ES&S election machines. Montana has ES&S.
- Our election system was stolen using PID controllers.
- The 2020 Presidential Race was not an Election.

- The outcome of the race was predetermined to be a "win" for Biden.

10. Ballot injection by the poll workers
11. Media manipulation (Social Media & News Networks)
12. State governors changed voting rules outside of the state legislatures
13. Unmonitored drop boxes
14. Barring unbiased and Republican witnesses during counting
15. Voting even though no longer living at residence
16. Nursing home coercion
17. Disposing of ballots

20. Use of Sharpies

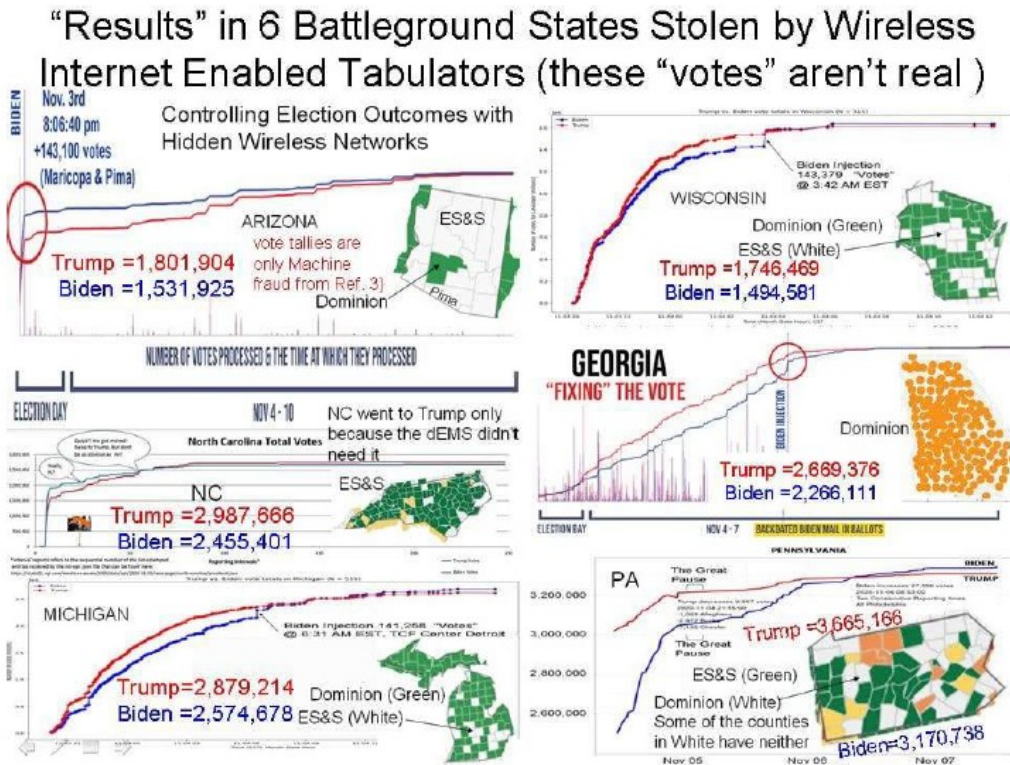
This presentation only deals with Item # 1 above.

### Conclusion

The main point of this presentation is that nearly 100% of the registered voters in each State are serviced with Tabulators that are connected to the Internet.\*

- The State PID Trackers operate close to critical damping to resemble election counters, i.e. smooth.
- Critically dampen controllers have slower response time and may cause the set points to be changed to produce the desired result in each state, easily done.
- The votes are manipulated in real time across the Wireless Internet to produce the pre-determined election outcome.
- The steal is actually happening in all 51 states including DC and this is why nationwide audits are a must!
- They know the outcome beforehand, ALWAYS GLOBAL BEFORE LOCAL.

## **Summary**

So This Is How They Stole the 2020 Election.

They know the outcome beforehand. In the Early Voting, the Trump votes are likely the first to be discarded. Run the Tracking Simulation (i.e., a 'Cruise Control' type algorithm) to its predetermined set points, deleting as many Trump votes as you can in Real-Time while also adding necessary ghost votes for Biden from an almost infinite supply of fake 'registered' Independents.

After the Election, assign Phantom names and addresses to the ghost votes. If any of the ghost votes are actually real people they'll never be contacted by either Party because they are Independents. Now delete all the unnecessary Phantom voters from the registration rolls before any Auditor notices. Then hide all the Phantom voters included in the rigged counts of each State by down-streaming back to the Tabulators LONG AFTER THE POLLS ARE CLOSED.

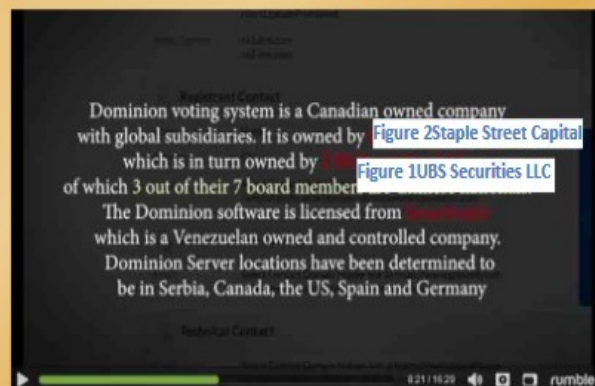
The voting machines belonged to a company called Dominion Voting Systems. Dominion Software is used in 28 US states including all of the battleground states or swing states.
