My name is Gary Kreep. I am Executive Director of the <u>United States</u>
Justice Foundation (USJF).

And, for 33 years now, we have been rightly known as the "legal arm of the conservative movement."

- 2) <u>The Constitutional issue</u> of Mr. Obama's and Eric Holder's Department of Justice argument, saying that ordinary citizens -- <u>meaning you and me</u> -- do not have "standing" to challenge the eligibility of a candidate for President.
- 3) <u>The Constitutional issue</u> of ensuring, through the states, that eligibility is confirmed before a candidate is allowed on the Presidential ballot (<u>this is what we plan to argue before the U.S. Supreme Court</u>).
- 4) The issue of whether Mr. Obama was adopted by his stepfather, Mr. Sotero, and as a result lost any U.S. citizenship that he MAY have had.
- 5) The issue of Mr. Obama traveling to Pakistan in the 1980s, using a non-U.S. passport -- he has stated that he did not obtain a U.S. passport until he was a U.S. Senator (2004, or later).
- 6) Why does it appear that Barack Obama has no valid Social Security number?
- 7) And, why does it appear that Barack Obama never properly registered (as required by law) for the Selective Service System?

Bottom line? There are still <u>many</u>, <u>many</u> questions swirling around Barack Obama's birth, citizenship status, and his eligibility to serve as President of the United States.
