Dear Patriotic Friend,

With so much disdain for the U.S. Constitution, Barack Obama thought that he could browbeat the American people into believing his lies.

You see, **Mr. Obama actually thinks that you and I are too apathetic to call his bluff.** He looks down on the citizens of this great nation so much that **he thinks that you and I are too stupid to catch him in deception.**

My friend, Barack Hussein Obama is wrong!

The United States Justice Foundation (USJF) has been onto Barack Obama since before the 2008 election. And USJF has been righting the wrongs caused by Mr. Obama's leftist allies for decades.

Not only that, the United States Justice Foundation is on the front lines of the war to reveal the truth about where Barack Obama was really born, and how the leftwing media is conspiring to cover up the biggest crisis that our nation has ever faced.

USJF is **defending grassroots Tea Party patriots in court against slanderous attacks by angry, left-wing, judicial activists** who see their hold on power slipping away.

And now USJF attorneys are **pursuing groundbreaking legal actions**

against Barack Obama . . . the "pretender to the throne," who has refused demands to prove his eligibility to serve as President of the United States, and who is rapidly turning our nation into a socialist dictatorship.

But this stunt, the release of a proven falsified "birth certificate" in April 2011 may prove to be the most prideful example of contempt ever shown toward the American electorate!

Despite the fact that Mr. Obama and his liberal minions deride as "crazy birthers" those of us who stand up for the integrity of the U.S. Constitution, the truth of Barack Obama's eligibility to occupy the Oval Office, as defined by Article 2 of the Constitution, is still very much in doubt.

As a matter of fact, experts in a variety of fields continue to point out discrepancies and inconsistencies with the document that Mr. Obama claims to be his long-form birth certificate, and these falsifications are too glaring to ignore.

National security expert Major General Paul Vallely (retired) says that the document released by the White House is a fraud. He also states that, "We've had three CIA agents, retired, and some of their analytical associates look at it, and **all came to the same conclusion, that even the long-form was a forged document.**"

And new questions as to why the delivering physician's name on the April 2011 document is different from previous reports . . . why Mr. Obama's "certificate" varies in form in at least a dozen instances from other Hawaiian long-form birth certificates of that era . . . and why the

Yet, Barack Obama's cronies deride these truth-seekers, and you and me, as "carnival barkers." But I believe that the facts will soon speak for themselves.

And, when the fact that the supposed President of the United States has criminally duped and laughed at the American people, "It will surpass all previous scandals, including the Watergate scandal of the Nixon administration", at least according to Doug Vogt.

Mr. Vogt is a business owner and an internationally-recognized authority on typesetting, document imaging, and scanning. And he is so convinced that the "birth certificate" is a fraud -- and so disgusted with Mr. Obama's trickery -- that he filed a **criminal complaint with the FBI demanding that "fraudulently created document" be investigated.**

Experts cannot deny the audacity of Barack Obama and his apologists. He has pledged to spend USJF out of existence . . . and he has already reportedly spent over \$2 million fighting USJF's eligibility lawsuits, and those of our allies.

This, despite the fact that a growing number of specialists, from private investigators to typographers, continue to assert that **the April 27, 2011 "long-form" released by the Oval Office is a blatant attempt to deceive America**, and the world, in order to hold on to the White House and to implement the long-held dreams of leftists and Marxists everywhere. He's already used it to steal two presidential elections!

In fact, former Hawaii senior elections clerk, Tim Adams (a self-described Democrat), who served in that official capacity during the 2008 presidential campaign, has signed a sworn affidavit stating that no long-form birth certificate existed in Hawaii's state files when he worked there.

And now, even the veracity of the cut-and-paste images of the registrar's stamps, as well as the variable type font used within the document -- *neither technology was available in 1961* -- are held up by experts as "**irrefutable proof**" that **Mr. Obama's long-form birth certificate is a forgery!**
