Dear Mr. Venrick,

- C) <u>Determine</u> if Barack Obama and members of his staff have conspired to coverup evidence that will prove that he is not eligible to serve as President.
- D) <u>Launch</u> impeachment proceedings to determine if he has committed "high crimes and misdemeanors," by falsely claiming that he is a natural born U.S. citizen.

Over, please...

E) <u>Demand</u> that the Justice Department begin legal proceedings against Mr. Obama, and all others who have illegally conspired to hide the truth about Mr. Obama's Presidential eligibility status.

Please, the evidence that Barack Obama was $\underline{\text{NEVER}}$ eligible to serve as President continues to grow...

... and I'll detail this evidence in a moment.

This should be THE top issue of your Representative, and of the entire Republican-led House of Representatives... and with your continued help it can, and will, be this fall.

As you well know, USJF has been proud to be $\underline{\text{THE}}$ organization that forced Barack Obama in 2011 to release what he claims is his real birth certificate.

I know that many have said this document put an end to the controversy over Mr. Obama's birth, and his eligibility to serve as President.

But with all due respect, they were, and are, dead wrong.

In fact, we remain convinced that Barack Obama is deliberately concealing the truth about his birth and about his citizenship.

We also believe that with Barack Obama, Jr. now rapidly accelerating his socialist agenda...

... <u>our efforts may be all that stands between Barack Obama's</u> <u>growing tyranny</u> and catastrophe for our economy, for our liberty, and for our security!

You see, well before he began abusing his power through the IRS and other federal agencies, we believe that he had <u>ALREADY</u> violated a series of federal laws and is <u>subject to prosecution</u> and, yes, <u>impeachment</u>.

Because <u>again</u>, there remain many unanswered questions surrounding Mr. Obama's past that go right to the heart of the question of whether he was ever eliqible to run for, and serve as, U.S. President.

Ouestions that include:

1) The authenticity of the long-form birth certificate that Mr. Obama released in 2011. Experts have argued that the typewriter used to fill out this form did not exist at the time of Barack Obama's birth. Plus, Mr. Obama's birth certificate was filled out differently than others done at the same time, in the same hospital. And, there is evidence that the form was prepared using a computer not in existence in 1961. Why? We are determined to find out the truth about these issues, with a team of independent forensic experts.

- 2) The Constitutional issue of Mr. Obama's and Eric Holder's Department of Justice argument saying that ordinary citizens -- meaning you and I -- do not have "standing" to challenge the eligibility of a candidate for President.
- 3) The Constitutional issue of ensuring, through the states, that eligibility is confirmed before a candidate is allowed on the Presidential ballot -- this was our Keyes v. Bowen litigation that we appealed to the United States Supreme Court.
- 4) The issue of whether Mr. Obama was adopted by his Indonesian stepfather, Mr. Sotero, and, as a result, lost whatever U.S. citizenship that he may have had.
- 5) The issue of Mr. Obama traveling to Pakistan in the 1980's using a non-U.S. passport -- he has stated that he did not obtain a U.S. passport until he was a U.S. Senator (2004, or later).
- 6) Why does it appear that Mr. Obama has no valid Social Security number?
- 7) Why does it appear that Barack Obama never properly registered (as required by law) for the Selective Service?
- 8) And, <u>did Barack Obama use Indonesian citizenship papers</u> to get into his first college, Occidental, in California?

Again, many questions. And the bottom line is this: If there is nothing at all in Mr. Obama's history that he may want to hide...

- ... why has he fought tooth-and-nail against our every effort in court to secure the release of key documents about his past,
- ... why was he so willing to reportedly spend more than \$2 million in attorney fees to silence this campaign,
- ... and why, if what he presented in 2011 was, in fact, a valid birth certificate from Hawaii, did he wait almost three years since the first eligibility suit was filed to release it?

This last question is, to me, the most puzzling.

But whatever the reason, his socialist agenda threatens to destroy our great nation, and forever transform it into a second-rate country.

And now, Mr. Obama believes that nothing stands in the way of this goal.

Well, we intend to prove him wrong!

How? Through a massive public education campaign, to ensure that

millions of Americans know exactly what the potential crimes by Barack Obama may be.

They include:

- 1) False Personation of an Officer or Employee of the United States.
- 2) Conspiracy to Commit Offense or to Defraud the United States.
- 3) Activities Affecting Armed Forces During War.
- 4) False Statement in Application for, and Use of, Passport.
- 5) False Personation of a Citizen of the United States.
- 6) Perjury.

If Mr. Obama ran for President, and vowed an oath of allegiance to our Constitution upon his inauguration... all the while knowing that he was not a natural born U.S. citizen and, thus, was unqualified to do so...
