Dear Friend of APC:

APC's battle against Sustainable Development is heating up. And now we face one of our greatest challenges.

You and I must act now to stop a fast-moving bill.

Senator Christopher Dodd has introduced the "Livable Communities Act" (S-1619).

And it has already been passed out of the Senate Banking Committee and is ready for a floor vote.

Please act immediately – sign and return the enclosed petition to Senate Minority Leader Mitch McConnell to demand that Senate Republicans stand strong AGAINST the "Livable Communities Act."

I'm not even going to bother sending a petition to Senate Majority Leader Harry Reid. He is four square behind this terrible bill.

But the Republicans **MUST** hear from you.

They **MUST** know we oppose S-1619. And they **MUST** stand solidly against it's passage in the Senate.

So please, right now, sign your petition and send it back to me at APC right way.

Let me tell you why we must stop the Livable Communities Act.

I've told you all about the wrenching transformation Sustainable Development will bring about in our nation.

It is a UN policy that will destroy our economy.

But Sustainable Development is much more than that.

It is a blue print to completely restructure our society. It will dictate population control – how many kids you can have.

It will dictate how or if your private property can be used.

It will dictate your health care – sustainable healthcare is the root of Obama care and it openly calls for rationing of healthcare – keeping it from the sick and elderly who are no long "of use" to society.

You know it all. I have sounded the alarm for several years about the dangers of the UN's Agenda and Sustainable Development.

But, up until now, there has never been a FEDERAL bill to impose Sustainable Development.

It has mostly been handled through Executive Orders or through local and state programs.

But now, Dodd's Livable Communities Act is the first to create a federal program to move Sustainable Development across the nation.

The Livable Communities Act will establish a \$4 billion grant program to "encourage" communities to impose Sustainable Development policy.

Dodd assures us that it is "purely voluntary."

But the bill also establishes a federal office to oversee the program called the Office of Sustainable Housing and Communities (OSHC).

A new "Development Czar" to enforce this program!!! How voluntary do you think it will be minutes after this horrible legislation is passed?

Here's how these voluntary grant programs actually work.

First, groups like the Sierra Club and the Nature Conservancy helped write the bill. They know everything that's in it.

As soon as it is passed by Congress, local chapters of these groups – and hordes of other similar radical environmental groups, will begin to pressure local mayors and city councils to apply for the "grants."

If your community's local representatives try to resist, the environmentalists will begin to apply massive pressure. They will tell the local newspaper that the city fathers are cheating the taxpayers out of federal funds by not applying.

They will haunt city council meetings demanding they accept the grant.

They will lobby. They will make campaign funds available to those who go along. They will move to destroy those who don't.

Finally, when city council caves in and applies for the grant, your community will be changed forever.

UN groups like the International Council for Local Environmental Initiatives (ICLEI) will descend on your town and begin writing legislation to set up unelected boards, councils and regional governments to control, development, water, road building,

historic preservation, school programs, population control.

I've warned you about ICLEI!

They are helping to transform America's towns and cities into little soviet where you have no voice in what happens to your own property or family.

They will create zoning that will not permit housing outside a certain area – limiting the growth of your community and forcing up the price of property.

According to the bill, Dodd's legislation will ***“prod local communities toward high-density, public transit-oriented neighborhoods that concentrate large numbers of people into small geographic areas connected by trains and bus networks.”***

Do you understand what that means?

You will be forced out of your suburban home and car – into high rise buildings in the inner city where crime is rampant and city taxes are skyrocketing.

Once this bill is passed – there will be no escaping it.

Second, for those who already have homes in the community, you will be forced to “comply” with rules and regulations to meet “sustainable standards.”

That means you will have to replace roofs, windows and appliances. This was done in Oakland, California and it costs every single homeowner an average of \$35,000.

Can you afford that?

Can our nation afford another \$4 billion in such grants – and you know it will cost much more than that!

You and I have no choice. We must stop the Livable Communities Act.

Please sign you enclosed petition to Senate Minority Leader Mitch McConnell to demand that Senate Republicans stand up to pressure from environmental groups and opposed this bill.

You know the American Policy Center has been the single leader in the nation working to sound the alarm and stop Sustainable Development.

We are making amazing progress exposing it to community leaders. But we have a long way to go.

Sustainable Development and Agenda 21 have massive support across the nation and internationally. But people are beginning to listen to us. The Sustainable Development “house of cards” can very well crumble just like the global warming hoax

has.

Will you help me continue to lead this battle against Sustainable Development? If we don't stop it, every community in America will be a little soviet, dictated to by unelected, uncaring bureaucrats.

The fact is, you and I cannot save our Republic if our cities and towns are run like little soviet!!!!
