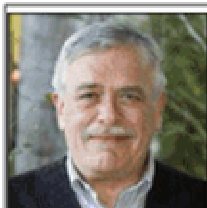

Knowledge is power. Come and join us on October 30th & 31st, 2010 for a seminar on wetland science and related laws. (Please look at the attached flyer).

Save yourself a lot of grief and money by being informed. This will also help in monitoring and encouraging the proper language in legislated regulations.

Did you know:

Because most wetland scientists do not understand wetland hydrology, what anaerobic means, or what reducing means and they do not understand the

difference between normal forest organic soils and "histosols" (which are "hydric" organic soils), they often misclassify a site as a wetland that is actually an upland or in many cases a well tended garden that has had a lot of organic augmentation added to the soils.

In the long run, soils cannot form in high energy environments, and what you see are geologic deposits or as the soil scientists call them, parent materials the soils will form in when they get the chance.

First, you must have soils before you can have hydric soils, and most wetland scientists do not understand this.

The SMA and GMA definitions of wetlands include: "Wetlands do not include those artificial wetlands intentionally created from non wetland sites, including, but not limited to, irrigation and drainage ditches, grass-lined swales, canals, detention facilities, wastewater treatment facilities, farm ponds, and landscape amenities, or those wetlands created after July 1, 1990, that were unintentionally created as a result of the construction of a road, street, or highway."

Lots more to learn!
