- This is more abdication, i.e. BREACHING of OUR public land and water by pandering to the tribes who are used by a global to local elite political bodies for profit and personal power.

- This is also what happened with the Confederation of Kootenai and Salish Compact which narrowly passed in Montana **approving** more taking of water in Montana April 2015 and the Kerr Dam.

- Our Flathead Electric Coop new category of charge labeled “Demand Rate” for power use during peak hours of 7-10AM & 5-8PM M-F has gone from \$0.26/KWH in June 2019 to \$2.26/KWH current end of 2023.
  - Federal Bonneville Power distributing the federal dams’ power is starting to squeeze the coops when their customers demand more power during common peak use times all while the extremist make deals with the feds and tribes to take down more hydro dams while cutting out the locals from coordination.
